WAIVER OF LIABILITY

APPLICATION TO PLAY OR OBSERVE PAINTBALL

THIS IS A LEGALLY BINDING DOCUMENT, PLEASE READ IT CAREFULLY

1. I understand that I may be injured or die while playing paintball.
2. I understand that even if all the safety rules are followed, that paintball is an inherently dangerous sport. I freely and voluntarily accept the risk of injury or death from participation in paintball and/ or from being a spectator.
3. I understand that serious and permanent eye injury, including loss of eyesight, can occur if I do not wear approved paintball safety goggles in any area where paintball markers may be intentionally or accidentally discharged. **I agree to never remove** my goggles under any circumstance while I am on the playing field, at the target range or any other area where I may be struck by paintballs.
4. I understand that, although the field operator and the staff will attempt to enforce safety and playing rules, I may be injured or die because other persons did not follow the rules.
5. I understand that I will be exposed to risks and hazards while on these premises. I freely and voluntarily acknowledge these risks and hazards and nonetheless wish to play paintball and/or enter onto these premises.
6. I understand that playing paintball involves risks, which include but are not limited to, the risk of injury from being hit by paintballs, injuries from possible malfunction of equipment used in the game, and injury from falling over natural or man-made obstacles on the game fields.
7. I certify that I am in good health and that I do not have a heart condition, ailment or condition which could be worsened or cause me injury, illness, or death as a result of exertion involved in playing paintball. I understand that I am responsible for consulting a physician before playing paintball.
8. As a condition of playing paintball on these premises and/or to be allowed on these premises, I knowingly and voluntarily waive my legal rights that I may have against the field operator, the land owner, equipment manufacturers and distributors, Velocity Paintball, Velocity Park LLC, its owners, employees, directors, and officers.
9. I agree to hold harmless each and all of the above parties, and to indemnify each and all of the above named parties against, any and all claims, actions, suits, costs, expenses (including attorneys fees), damages, and liabilities arising out of, connected with, or resulting from my playing paintball.
10. I understand that I must sign this Waiver as a condition of being allowed on these premises and/or to play paintball. I also understand that no one, including the field operator, has the authority to change any of the terms of this Waiver.
11. I understand that I am fully liable and financially responsible for the equipment issued/rented to me. I also understand that I am financially responsible to Velocity Paintball for the **loss or damage of any such issued/rented equipment**, structures or property of Velocity Paintball.

ON THE BACK OF THIS FORM IS VELOCITY PAINTBALL'S FIELD RULES. YOUR FAILURE TO FOLLOW THESE RULES WILL ENDANGER OTHER PLAYERS AND YOU WILL BE REMOVED FROM THE PREMISES.

VELOCITY PAINTBALL SAFETY RULES

All players must follow all safety and game rules without exception. Any violation of these rules can result in that player being ejected from play or the premises at the sole option of the management.

1. Paintball approved goggle & facemask **must be worn at all times** while in shooting range and playing fields. Goggle systems should be unmodified and consist of factory approved parts.
2. **Barrel Covers are required in staging area/parking lot.** Plugs, squeegees, battle swabs and other objects can not be used as barrel blocking devices. **Trigger guards are required, NO EXCEPTIONS!**
3. All Markers will be chronographed to 290 fps or less. Field Staff will chronograph rental equipment prior to use. **Players will NOT adjust velocity on rental equipment.**
4. No shooting into or out of the registration area, neutral zones, or parking areas. All markers must have safeties on and barrel covers on when not on the playing field. **Markers may only be discharged on the playing field or at the target range.**
5. **No** climbing of structures of any kind.
6. **No** physical contact or threatening verbal abuse.
7. No potentially dangerous gear. Players may not bring any form of tools onto the playing field. No types of pyrotechnics or explosives are allowed. Field staff must approve all personal equipment. **NO Full Automatic, Turbo Mode or Burst Mode firing allowed.** Markers capable of these modes must be set to semi-auto, meaning one ball fired with each single pull and release of trigger.
8. The "Surrender" rule is in effect, use your best judgement.
9. No setting traps. Players will not move or alter field obstacles in any way.
10. No alcohol or illegal drugs are allowed on the premises or in the parking area.
11. **Smoking is not allowed on playing fields. Use supplied cans in staging area for cigarette butts.**
12. Do not attempt to disassemble rental equipment or remove a Co2 tank from a rental marker.
13. No blind shooting. Players will always look in the same direction they are firing.
14. Referee's calls are final. No players are allowed to argue with any referee.
15. I agree to abide by all safety and game rules.
16. I agree to **never** intentionally shoot at any objects/persons outside of the playing area/shooting range.
17. I understand that intentionally shooting at any person or vehicle **not participating** in paintball games can result in a **misdemeanor or felony**. I also understand that the **police will be notified** if I intentionally try to hurt anyone or damage others property with a paintball marker.
18. I have read each and every item on this Waiver.
19. I understand each and every item on this Waiver.
20. **I agree to only use paintballs purchased at Velocity Paintball Field or Retail Store.**
